- Orange Train Stn: AM Discharge on Route 280 side of platform and PM pickup on Main St. side of platform next to Depot Bldg South Orange Train Station: AM Discharge and PM Pickup located on S. Orange Ave westbound at railroad overpass. Mountain Train Station: AM Discharge in parking lot adjacent to inbound platform.
- Valley Road Parking Lot - Stop is in rear next to permit parking. For permit information call (973) 325-4040.
- For PM service, shuttle bus arrival times at neighborhood stops are approximate.
- L - Shuttle Bus may leave ahead of schedule after train arrives in station.
- Bus trip No. 12-01, first PM trip from Orange runs Routes 1 and 2.
- Bus trip No. 12-11 from South Orange runs Routes 1 and 2.
